As this is the third year for the Summative Alternate ELPAC, a third column of score history was added to the Change Over Time web page. The ability to select a display type of both number and percentage of students, percentage of students, or number of students was added to the following web pages for Summative ELPAC and Summative Alternate ELPAC: Change Over Time Search/Compare Results School-District-State Comparison Messages were added to the Initial ELPAC and Summative ELPAC for the student group of "Disability Status" as to why the data was not available, as well as instructions for next steps. A web page of the ELPAC scale score ranges was added. Links to the web page were added to the Detailed Results, Change Over Time, Search/Compare Results, and Understanding Results web pages. A note was also added on these web pages to explain the change in scale score ranges for the 2018-19 test administration. The message directing the user to the Summative ELPAC Understanding Results web page for additional information, was revised. The performance level descriptors on the Initial ELPAC Understanding Results web page. 

Date October 2023	 Changes or Updates Made to Public Web Reporting Site The 2022–23 Initial ELPAC, Initial Alternate ELPAC, Summative ELPAC, and Summative Alternate ELPAC test results were released. The Initial Alternate ELPAC program was added. Error messages were updated with additional information as to why certain data was not available, as well as instructions for next steps. The information bubble icon on the Detailed Results web pages was replaced with a new icon, and the text within the information bubbles was made generic for the year, test, and subject. Paragraph wrapping for notes and informational text on the web pages in the application was changed to be left-justified and continued to the end of the web page before wrapping. The "Overall Mean Scale Score" section on the Grade Reports web page was changed to use the same size graphic for the level and the same size font for the overall score as the composite score sections. Sort features were added to the search table at the bottom of the Search/Compare Results web page, a new View All Schools list was added that displays all schools, including charter schools, by county and district. All lists in the "View County, District, or School The student group names for Economically disadvantaged were changed to Socioeconomically disadvantaged and Not socioeconomically disadvantaged. New English learner (EL) student groups of Long-Term English Learner (AR-LTEL), and Never-EL were added to the About web page,

The level references for the Summative Alternate ELPAC were changed to show both level and descriptor only on the Test Results at a Glance web page and only the levels on all other web pages. The level references for the Summative Alternate ELPAC were changed to show both level and descriptor only on the Test Results at a Glance web page and only the descriptors on all other web pages. On the About web page, the Student Enrollment Counts label was changed to Number of Students (Enrolled, Tested, and Tested with Scores). The English language fluency definitions were moved from the individual program Understanding Results web pages to the About web page. The definition of Number of Students Tested with Scores was updated on all Understanding Results web pages.
April 2023	 The Change Over Time tile was removed from the Test Results at a Glance web page for the Initial ELPAC. The suppression message was updated to reflect that enrolled and tested counts will be suppressed for fewer than four students. Assessment results are still suppressed for fewer than 11 students. The Change Log was updated for the 2021–22 test administration year. The Research Files web pages were corrected to show both TXT and CSV file extensions. The Understanding Results web pages for the Initial Alternate ELPAC and Summative Alternate ELPAC were updated with a link to the Alternate ELPAC Performance Level Descriptors web document. The Understanding Results web page for the Summative Alternate ELPAC was updated with the correct reporting level descriptors.



	 A new aggregation of EL—less than 1 year in program was added to the ELs Time in Program group.
	 The About web page was updated to include expandable and collapsible student groups sections, school type definitions, and suppression rules.
	 The tiles on the home page were rearranged for better appearance.
	 The name of the higher-level institution associated to the entity displayed in the search results on the Test Results at a Glance web page was added.
	 The county/district/school code was added to the search results grid on the bottom of the Search/Compare Results web page.
	 Charter schools and noncharter schools were added to the School Type filter, allowing aggregation by those values.
	 The application was enhanced to print the data on the screen in a more-formatted report format, eliminating some of the screen header information and menu items. This was done on all pages with print capabilities.
	 Hosting of the application and all environments, including the public site, was moved from the California Department of Education (CDE) to ETS.



	 Navigational links were added to the About web page.
	 Suppression rules were updated to display student enrolled and tested counts greater than three. If there were enrolled counts but no tested students, a zero was displayed in the tested and tested with scores counts.
	• The search results on the Test Results at a Glance web page were enhanced to display the results in the entity list with their parent entity information (schools with their district, districts with their county, and counties with the state.)
	 Instructions were added on the Research Files web page for importing caret-delimited files.
	 Additional text of "(No Data Available)" was added for 2019–20 in the Year filter for the Summative ELPAC Report Options.
	 When data for 2019–20 was requested on any web page, because there were no results, the error message displayed for the Summative ELPAC was updated to read, "2019–20 results are not available due to the suspension of testing as a result of the novel coronavirus disease 2019 (COVID-19)."
	 Change Over Time web pages and functionality for both the Summative ELPAC and Initial ELPAC were added.
	 The Grade Reports web page was made dynamic for the Summative ELPAC, allowing the user to choose year, grade, student group, and school type values.
	 A new student group value of "Not migrant" was added to the Migrant student group, which will be applicable only for the 2020–21 test administration forward.
	 A new student group of English Learners Time in Program was added for the Summative ELPAC, which will be applicable only for the 2020–21 test administration year forward.
	 New student groups of Military Status and Homeless Status were added for the Initial ELPAC, which will be applicable only for the 2020–21 test administration year forward.

	• On the Test Results at a Glance web page for the Summative ELPAC, for the 2017–18 test administration year only, a proficient percentage was not available, and the message displayed regarding proficiency criteria was replaced with the following: "For the 2017–18 administration year, suppression was done based on the percentage value at each level rather than the total number tested with scores count that the percentage was calculated from."

The site was updated to enhance accessibility and usability. A new home page with a tile design, including a tile for the California Assessment of Student Performance and Progress, was added. The Test Results at a Glance web page was added. A new search on the Test Results at a Glance web page allowed the user to select an entity from a drop-down list. The drop-down list was displayed with the third character entered. An updated search screen allowed searching for entities that contained the characters entered. A link to the CDE California Assessment Results News Release web page was added.
